

**CBS.com REALITY PROGRAM
ELIGIBILITY REQUIREMENTS**

1. An application form, release waiver, and an audition scene for video submissions are available for downloading from this website. We must receive the completed Contestant Application, Release and Waiver and video submission (collectively "application materials") at Producer's mailbox address indicated below no later than Wednesday, May 17, 2006, at 5:00 p.m. Pacific Standard Time. Producers reserve the right, in their sole discretion, to extend the deadline as appropriate.
2. Semi-finalists could be invited to audition for Producers sometime in May 2006. All expenses for these auditions, including travel to and from the auditions, will be the applicants' sole responsibility.
3. Approximately eight (8) finalists (the final number of which will be determined by Producers, in their sole discretion) will be selected as participants to participate in a new CBS.com reality program (the "Program"). Filming is presently scheduled to occur between June and August 2006 (or as otherwise scheduled by Producers) in New York City.
4. All decisions made by the Producers are final and not subject to review or appeal.

So, now you're probably wondering what kind of person is eligible to be selected for this once in a lifetime opportunity. Here are the guidelines:

- Employees, officers, directors and agents of CBS Broadcasting Inc., CBS Digital Media, Procter & Gamble Company, Inc., TeleVest Daytime Programs, Inc., P&G Productions, Inc., As The World Turns and/or of any of their respective licensees, assigns, parents, affiliated and subsidiary companies and the immediate family (spouse, mother, father, sister, brother, daughter or son, regardless of where they live) or members of their same households (whether related or not) of such employees, officers, directors and agents are not eligible to be applicants on the Program or participate in this application process.
- All applicants must be between 18-25 years old at the time of application.
- All applicants must be United States citizens and be living in the United States.
- All applicants must be in excellent physical and mental health.
- All applicants must authorize Producers to conduct a background check.
- All semi-finalists will be required to complete and timely return the Medical History Form (to be furnished to the selected applicants).
- Applicants who are selected as participants cannot be candidates for public office until after the initial broadcast of all programs in which they appear.

Beyond these basic qualifications and any additional qualifications set forth in the Contestant Application, we are looking for a diverse group of men and women who represent a broad cross-section of American society. Our competitors will also need to be able to live in close quarters with other participants.

Participants will be selected based upon having the following traits:

- Acting talent and natural ability to perform
- Outgoing personality
- Ability to memorize

- Willingness to take direction
- Capability to successfully work in an ensemble

The prize for this competition is a thirteen-week contract role on *As the World Turns*, but this prize will not come easily. Participants in the competition for the prize must be willing to commit to traveling and living in New York City with the other participants in accommodations provided by Producers for approximately four (4) weeks in two (2) separate two-week intervals. Participants will be filmed up to 24 hours a day by television camera crews. The winner of the competition must be willing to relocate to New York City for the full term of the *As the World Turns* contract or longer should the contract be extended. Travel expenses to and from New York City and living accommodations for the duration of the contract will be paid for by *As the World Turns*, all other expenses will be the responsibility of the winner. Dates for the winning contract will be determined at a later date by *As the World Turns*.

FAQ

These answers to Frequently Asked Questions should help guide you through the casting process:

1. What are the guidelines for my video?

All videotapes must be your best performance of the designated scene provided for download. The video must be a VHS or DVD (No mini-DV's, 8mm or VHS C). To transfer the other formats to VHS, simply connect your camera to your VCR and record. Use this video to show us what's special about you. Make sure you label your tape with your name.

2. What if I don't have a camera?

Borrow a friend's or relative's camera. Beg and plead if you have to, because all applications must be submitted with a video.

3. How will I know if I have made it to the next round?

Finalists will be notified by June 5, 2006 using contact information provided in the application. Applicants that are not selected will not be notified.

4. How do I know if you received my application and video?

Unfortunately, due to the high-volume of mail we anticipate receiving from applicants, we will not be able to answer any questions about the receipt of your application and video. All the major courier services can track packages, so we suggest that you send it via one of them.

5. What type of contestant are you looking for?

There is no one type of participant who will be chosen. We are looking for a wide variety of people who will bring energy and excitement to the contest. All applicants must meet the guidelines and have the traits specified in the Contestant Application and the Eligibility Rules sections of this website.

6. I can't afford to take four weeks off work. If I am chosen to be a participant, will I be compensated for my time?

Provided that the program is broadcast and the winner complies with all of Producers' requirements, the winner will be awarded a thirteen-week contract on *As the World Turns*, which will include weekly compensation (AFTRA scale). The other participants will receive free airfare to and from New York City, if applicable, and accommodations during production of the Program.

7. Can I get my application video returned to me?

No. All videotapes will become the sole property of the Producers once submitted, and will not be returned to you, whether or not you are selected as a participant.

Contestant Application**

You may apply to be a contestant on the Program by completing and submitting this Contestant Application, along with the Release and Waiver and the video submission.

Please note the following eligibility requirements must be met in order to proceed with the application process.

You must be willing to travel at your own expense to audition (should in-person auditions take place). Producers reserve the right to choose the location of the auditions at any time and for any reason.

- a. You must be between 18-25 years of age.
- b. You must be a United States citizen and live in the United States.
- c. You must not now be a candidate for public office and must agree not to become one until after initial broadcast of all programs in which you appear, if selected as a contestant.
- d. You must be in excellent physical and mental health.
- e. If you are selected to audition, Producers will provide an Audition Agreement Package that must be completed. Audition Agreement Package includes a Background Questionnaire Form among other forms and agreements.
- f. To accept an invitation to be a contestant, you must complete, and timely return the Applicant Agreement Package, which will be furnished to you by the Producers, and will include, among other things, an Applicant Agreement, including Release Forms and Waivers for review and signature.
- g. If you are selected to audition, you agree to authorize Producers to conduct thorough investigations into your background and personal history.
- h. All applicants must have valid U.S. identification with proof of age and deliver a copy of such identification at the time of application submission.
- i. Employees, officers, directors and agents of CBS Broadcasting Inc., CBS Digital Media, Procter & Gamble Company, Inc., TeleVest Daytime Programs, Inc., P&G Productions, Inc., As The World Turns and/or of any of their respective licensees, assigns, parents, affiliated and subsidiary companies and the immediate family (spouse, mother, father, sister, brother, daughter, son, regardless of where they live) or members of their same households (whether related or not) of such employees, officers, directors and agents are not eligible to be applicants on the Program or participate in this application process.

Applications MUST be written clearly or typed and must be accompanied by a video which meets the following restrictions. Please do not include anything except the completed Contestant Application, Release and Waiver and the video. Failure to adhere exactly to these instructions may result in disqualification.

LENGTH: MAXIMUM OF ONE (1) PERFORMANCE of the designated scene provided on CBS.com.

FORMAT: Only VHS or DVD. (No mini-DV's, 8mm or VHS C). To transfer the other formats to VHS, simply connect your camera to your VCR and record.

DEADLINE EXTENDED: Wednesday, May 17, 2006, by no later than 5:00 p.m. Pacific Standard Time.

The video will become the property of the Producers and will not be returned to you, whether or not you are selected as a participant.

Applications will only be considered if they are complete. Complete applications consist of the following:

- a. Completed Contestant Application (including the signed Release and Waiver attached thereto).
- b. Copy or proof of a valid U.S. identification with proof of age.
- c. Photo of yourself or an 8 x10 headshot and resume if applicable.
- c. Audition tape of scene provided labeled clearly with your name.
- d. Print clearly on the outside of the envelope (including overnight mail envelopes) your return address in the upper left corner of the envelope.
